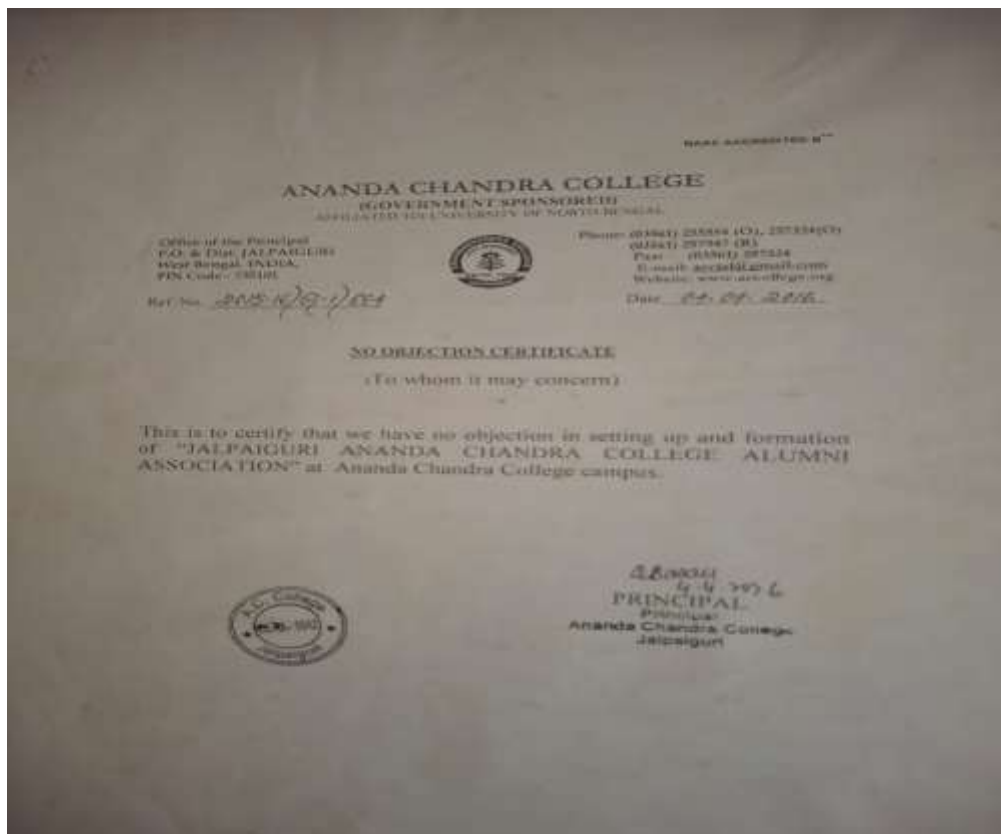


Registration of the Association


